4. DURATION AND RENEWAL OF AGREEMENT

5. AMENDMENTS

- 5.3 Should any disagreement arise of the application, interpretation or implementation of this agreement, the college shall endeavor to exercise best efforts to negotiate their differences.

6. TERMS

- 6.3 This MOU is without any legal & financial liabilities to any party.
- 6.4 MOU be treated as Null and Void in case of any types of differences between the both.

Duration
